It was asked if it would be easier for members to sign up if there was a QR code for speakers for Park Place. Tammy said that she would be willing to have one. And Bonnie would put it on the website. Kelly asked if anyone that had already spoken to take someone with them. Tammy and John both said they would be willing.

**Fellowship Focus.** Karen said that would anyone volunteer to coordinate the Make it Bake it. Linda M said she was willing to coordinate. And she would get someone to help her.

#### **Education Focus.**

Buddy System update. Olin said that it just started As We Understood book study. A member needed the book, and Olin told them that they needed to get with his buddy Pam H. to get the book. She is the literature coordinator. Jamie met Pam in person and was able to get her the book.

#### **New Business**

Karen said that Pam H had made a request about the finances of the Back-to-Basics workshop and how it functioned with District 10 and how it relates to money. Pam stated that the LDC is an example of how they are in the District but separate. And the chair of the LDC attends all the district meetings and presents a financial report. So finances are available for the district to review. Also, Alateen is another example of how they could separate the finances. Also, the Host Committee is another example of how it could work. Pam said she just wanted to discuss the idea of this. Bonnie said because it's a one-time event. It would only be active only 3 months of the year. A new person in charge each time and have to go change the names on the account at the bank. Bonnie did say that whoever coordinates the Back-to-Basics workshop should have a budget and still report at the meetings. Pam asked when a motion was made that District 10 would forever host and be financially responsible for the Back-to-Basics workshop from this day forward. Tammy O said from her relocation that she doesn't know that District 10 ever did that. She said that she thought District 8 was not able to do it anymore and so District 10 said that they

did not want it to go away. And so, District 10 did it that year. She also said that District 10 could decide the same thing and not want to host the workshop as well. Pam said that something needs to be in place so that down the road that if the workshop has a surplus or a deficit, that guidelines need to be in place. It may be uncomfortable. And if it's a deficit it may not be too much of an issue. But if there is a \$500 or \$1000 surplus then can we use this for public outreach or some other District project. Carolyn said she wasn't aware that the District had taken on the Back-to-Basics workshop. Carolyn said when she came into this District that the balance of the district was only \$4. I agree with Pam that we need separation whether we keep doing Back to Basics or not. Kelly asked the question about the Make it Bake it and no separate bank account for that event. I guess I see the workshop the same way. It's a workshop that the District is putting on for now. And its our District's money that puts it on and if we have a shortage then the district absorbs that and if it has a surplus then the district can funnel that money as the members see fit. Carolyn said that Make it Bake it was just a thing to do at Christmas. And then it was decided that the money raised would go to the district. Originally it was the group that got the money. Karen said that having a separate account and if the banks charge a monthly fee, then any profits made would quickly be taken away by the fees. Pam said that we could at least have a line item in the budget. Kelly said that she thought it was a budget line item. Bonnie looked at the budget and found in the 2025-line items for the expense and the income from the registrations. Kelly stated that the retreat is more about public outreach vs about making money. Amanada said that the Back to Basics was one of the things that got her into Al-Anon. She was thrown into doing a skit that got her out of her comfort zone but was rewarding as well. To me it's really important. Karen always said the goal was to break it even. Last year the reason for the deficit was the number of people who attended. Karen suggested that within the line item for Back to Basics and then further break down of that line item for expenses for food entertainment etc. Karen said that for the new year when the Treasurer is here, we can discuss the budget to include these things discussed. Karen said we have a budget now through December. But we want some discussion of what we want to do with line items. Karen said we need to have someone be a point person for the Back-to-Basics workshop so that they will know what they can do within the budgeting process. Karen suggested we go to our groups to get volunteers to head up the Back-to-Basics workshop even if it's a group of members too. Amanda asked about putting the deposit down for the workshop. And it was discussed how to reserve the campground. Amanda said the estimate was different than when she visited. Amanda and Tammy reviewed the proposal, and they included items we did not want. We took a 10-minute break. Karen identified the most important things for today. A break out budget, need information about a deposit, and the amount. Tammy stated the errors. Facility use per person per day they could knock at least one of those off if not two of those off. They also

added the zip line and swing. Also, the room number was 14 and there should be 10 rooms for each night. So, the estimate as stated now is about \$4900 and with these changes it should be about \$3200 divided by 25 people and it would be about \$128 per person. Karen said that the deposit should be done before November. But not comfortable with the contract. Get a new contract. Then over email get a consensus to send the deposit. Amanada asked if that was necessary if the deposit was less than \$850. Karen said no that would not be necessary. Kelly also asked if approved by the district to be the events coordinator. Tammy made the motion to elect Kelly as the events coordinator. Motion was seconded by John. Motion passed. Linda asked if she would be over the Make it Bake it. She said yes.
